As you aware, the National Commission for Protection of Child Rights (NCPCR) under section 13 (1) (j) of CPC Act, 2005 inquires into complaints and takes suo-moto cognizance in relation to deprivation and violation of child rights.

2. Commission has received a representation vide DOWCD from Jayanthi A regarding Delhi Public School Anandapuram is forcing the students to attend the physical classes. It was also mentioned in the representation that the said school is demanding to pay unregularised school fee against the Honorable High Court of AP Judgement (Copy enclosed).

3. Therefore, the Commission is forwarding the matter to you for taking appropriate action at your end, and dispose of the matter under the direct intimation to the complainant.

The Principal through class teachers is forcing the students to attend the physical classes, even the School has the provision to conduct the online classes through the school CRM App. They have conducted online classes in the previous week. And at the same time demanding to pay the unregularised school fee against the Honorable high court of AP judgment.</p> <p>Therefore, it is clear that the school is more interested in collecting the fees but not the safety of the children who are at great risk of Covid-19 exposure</p> <p>Several hospitals in the city have seen a significant rise in the number of severe Covid cases among children over the last seven days. Many children are landing in paediatric intensive care units (PICU), and taking much longer to recover than most adults, suffering from Acute Encephalitis Syndrome (AES), involving the brain, to severe pneumonia. A boy even died after he suffered a sudden deterioration (Ref: TOI)</p> <p>27-01-2022 Andhra Pradesh even as positivity rate jumps to 36% (Ref: deccanherald.com)</p> <p>We are not able to submit our issues related to the safety and security of Children since Delhi Public school Anandapuram didn't set up the Parent-Teacher Association as per the guidelines of CBSE and NCPCR.</p> <p>Therefore, I'm requesting you to kindly look into the grievances and pass necessary instructions to the school, and instruct the school to constitute the Parent-Teacher Association immediately.</p> <p>Yours Truly</p>
